SUMMARY OF NORTH-WEST REGIONAL ASSEMBLY DELIBERATIONS

June 2021 Session Deliberations;

- 1- Adopting the budget of the North-West Regional Assembly for the 2021 fiscal year in the sum of three (3) billion CFA francs,
- 2- Authorizing the President of the Regional Assembly to purchase eight (8) service cars,
- 3- Authorizing the President of the Regional Assembly to create commissions within the Regional Assembly,
- 4- Authorizing the President of the Regional Assembly to subscribe Insurance for the Assembly,
- 5- Granting remuneration, allowances and other benefits to the Secretary General and the Regional Treasurer,
- 6- Authorising the President of the Regional Assembly to recruit personel for the Regional Assembly,
- 7- Granting the President of the Regional Assembly a Housing Allowance,
- 8- Granting authorisation to the President of the Regional Assembly to negotiate and sign diverse conventions and partnerships,
- 9- Authorizing the allowances and other benefits allocated to guests or invited persons during sessions, commissions and meetings of the North West Regional Assembly,
- 10-Granting allowances to the Chairperson, members, and Secretary of the Internal Tenders' Board of the North-West Regional Assembly,
- 11-Granting remuneration, allowances and other benefits to members of the Regional Executive Council and deliberative organs.
- 12-Authorizing the President of the Regional Assembly to create the North-West Development Investment Fund (NOWEDIF);
- 13-Authorizing the Regional Executive Council to review and redo the Standing Orders with the Committees concerned, mindful of the corrections made for adoption during the next session;
- 14-Adopting the North-West Regional Assembly logo.
