### MINUTES OF THE APRIL 2022 EXTRAORDINARY SESSION OF THE NORTH-WEST REGIONAL ASSEMBLY.

The North-West Regional Assembly April 2022 extraordinary session, convened by the President of the North-West Regional Executive Council, Prof Fru Fobuzshi ANGWAFO III, held at the Regional Assembly building in Bamenda, on the first day of April, in the vear two thousand and twenty-two.

### FRIDAY, APRIL 1<sup>ST</sup> 2022.

#### JOINT SESSION.

The sitting of the North-West Regional Assembly April 2022 extraordinary session was a joint session of both Houses of the Assembly Chaired by Prof Fru Fobuzshi ANGWAFO III, President of the North-West Regional Executive Council.

After the arrival and registration of members of the North-West Regional Assembly, Members of Parliament, Mayors and other dignitaries, then followed the arrival at 8:20 am of the President of the Regional Executive Council, accompanied by the Representative of the State, Governor of the North-west Region, announced by the North-West unity gong.

The entire Assembly stood for the singing of the National Anthem after which Honourable Representative ADAMU ALI SULE and Honourable Representative Rev. ANYAMBOD Emmanuel ANYAH led prayers.

The President of the North-West Regional Assembly, on verification of quorum through roll call, gave the floor to the first Secretary, Honourable Representative KALAK Flavius BOTEH, who presented six (6) proxies from Representatives GHEJUNG AWUNTI.

The President then declared the session valid after noting a quorum of 83/84 members of the Assembly giving a 98.8% attendance.

The agenda of the first sitting of the session proposed by the Regional Executive Council was as follows:

- 1. Reading of the decision convening the April 2022 extraordinary session
- 2. Opening address by the President of the Regional Executive Council
- 3. Statement by the Representative of the State
- 4. The session adjourned at 9:00 am to reconvene at 2:00 pm
- 5. Presentation of the organizational chart of the Regional Assembly
- 6. Presentation of the 2022 budget adjustment
- 7. Presentation and adoption of deliberations
- 8. Closing remarks by the President of the Regional Executive Council

## Reading of the decision convening the April 2022 extraordinary session.

Decision No 2022/00556/NWRA/SG of 25/02/2022 convening an extraordinary session of the North West Regional Assembly for April 1st 2022 was read by Mr Peter GIYOH YERIMA, the Secretary General of the Regional Assembly.

# II Opening address by the President of the Regional Executive Council.

The President of the North-West Regional Executive Council, Prof Fru Fobuzshi ANGWAFO III, after dully observing protocol present, started by welcoming all who honored the invitation to attend the April 2022 Extraordinary session. He said the extraordinary session followed the March Ordinary session that ran from Monday the 28th to Thursday the 31st of March 2022 that saw the Adoption of the Administrative account, the Management account, and the Stores account. The Extraordinary session was dedicated to the examination of the Organizational Chart of the North-West Regional Assembly with its consequential budgetary implications. The draft proposal of the Organizational Chart to be debated upon was a result of the consultation work with the SPRA (the Permanent Secretariat for Administrative Reforms). The President called for frank deliberations regarding the Organizational Chart of the North-West Region to reflect the specificities of the North-West Region as stipulated by the Special Status. The President equally urged members to scrutinize carefully and contribute to the agenda of



the day with all their hearts and minds to give to the Region the Organizational Chart it merits and the concern for peace and development.

### III Statement by the Representative of the State.

The Representative of the State, H. E the Governor of the North-West Region, Adolph LELE L'AFIQUE when given the floor, recalled that as Representative of the State, the debates for the adoption of the Organizational Chart and the budget adjustment were going to be keenly followed. He encouraged the Assembly to make sure that all the deliberations of the day were made in keeping with the regulations of the Republic of Cameroon.

The Extraordinary session was suspended at 9:00 am to reconvene at 2:00 pm to permit the President of the Regional Executive Council and the Representative of the State have a working session with the Minister of Public service who was in Bamenda.

The Extraordinary session reconvened at 4:15 pm with a brief introductory word from the President of the Regional Executive Council.

### IV Presentation of the organizational chart of the Regional Assembly.

The Hon. President, Prof Fru ANGWAFO III gave the floor to the Questor, Hon. Rep WAINDIM Jude NSOM, who presented the Organizational Chart of the North-West Regional Assembly.

The President of the Regional Executive Council declared the floor open for discussions with respect to the presented Organization Chart and started by correcting the change of the service infirmary to clinic on the Organizational Chart.

The floor was then given to Hon Rep NCHECHUMA Pius BANLA who suggested that;

- ✓ The Mail, documentation and archives service be placed directly under the President
- ✓ The Service in charge of trade fares be assigned to the Communication, Cooperation and Public Relation Unit,
- ✓ The Introduction of a service for training under the Sub Department of Human Resources
- ✓ The Introduction of a service of interphase with the riverine population
- ✓ The Bringing out of a service for quality management on hygiene and sanitation



✓ The Introduction of a service for feasibility studies under the Department of infrastructure

Hon Rep ADAMU ALI SULLE, upon given the floor worried about the functions of the Commissioners with no direct link to any service. He expected to see an arrow from the elected officials to some of the technical services on the Organizational Chart and wanted to be clarified.

In response, the Hon Rep WAINDIM Jude NSOM, Questor explained that the link was from the five (5) assistant research officers placed under the Technical Adviser. One of the five assistant research officers was to liaise with the Vice President, three with the three Commissioners and one with the Questor and the technical services.

The President of the Regional Executive Council, Prof Fru ANGWAFO III then gave the floor to Hon Rep NGWANG NGWANYI Michael who after developing how the Mail, Documentation and Archives service are supposed to function, suggested to submit to the Regional Executive Council a proposal on the detail functioning of that service.

Hon Rep FUCHI Emmanuel DIANGHA when given the floor worried for the need to market the activities by introducing technical services in the areas of eco-tourism, promotion of natural resources, industry and technological development. He proposed the inclusion of a service for extension, promotion and vulgarization under the department of economic development.

The Secretary General of the Regional Assembly pointed out that the Regional Treasurer and the Revenue collector did not figure on the Organizational Chart and suggested that some little corrections needed to be effected.

### V Presentation of 2022 budget adjustment.

The President of the Regional Executive Council, Prof Fru Fobuzshi ANGWAFO III, then gave the floor to the Secretary General, Mr Peter GIYOH YERIMA who presented the 2022 budget adjustment. The 2022 adjusted budget of the North-West Regional Assembly balanced in revenue and expenditure moved from 3,538,000,000 FCFA to 4,348,819,555 FCFA. 39.92% was budgeted for Running Expenditure and 60.08% for investment expenses.



### VI <u>Presentation and adoption of deliberations.</u>

Hon Rep BENYELLA Godwin TAFOANG when given the floor moved a motion for the adoption of the Organizational Chart and the budget adjustment of the North-West Regional Assembly. This motion was seconded by HRH Fon Aaron KILLA BUMKANG followed by an acclamation.

Two deliberations were adopted and presented by the Secretary General Mr Peter GIYOH YERIMA as follows:

- 1- Adoption of deliberation organizing entities of the North-West Regional Assembly Organizational Chart;
- 2- Adopting the 2022 budget adjustment of the North-West Regional Assembly.

### VII Closing remarks by the President of the Regional Executive Council.

Hon. President, Prof Fru F. Angwafo III observed all protocol and thanked all for resilience and understanding with respect to the very long day. The President promised that the Regional Executive Council was going to serve the Assembly by transmitting the proposals of deliberations. He urged the various committees that proposed deliberations to continue even at a distance to nourish the Regional Executive Council with details to execute the various deliberations and better prepare for the June 2022 ordinary session. He thanked the special guest attending the extraordinary session and urged all to continue working for the best while keeping the spirit of looking in the same direction for the betterment of the lives of the Region. Prof Fru F. ANGWAFO III whished all a safe return and declared the April 2022 extraordinary session of the North-West Regional Assembly closed by striking the North-West Regional Assembly unity gong while all stood for the refrain of the National Anthem at 6:05 pm.
